This Citation Exercise is designed to show that you understand both the MLA and APA format citations for the most commonly used types of sources. Be sure to review the Citation Information handout from the instructor (or on the class website) as well as your handbook for how these citations should be formatted in both MLA and APA. Part a is the MLA version of the answers and part b is the APA version of the answers.

6. For this citation, you have the book *NurtureShock* by Po Bronson & Ashley Merryman. Review the scans of the title pages found through the online learning system or at <http://kosmicki.com/102/bookexercise.pdf> . Use the information found on the title page scans to format a complete APA citation for this source.

7. For this citation, you have the article “Lead Us Not Into Debt” by Megan McArdle from *The Atlantic*, a general interest periodical. Review the scans of the pages of this article found through the online learning system or at <http://kosmicki.com/102/generalexercise.pdf> . Use the information found on the page scans to format a complete APA citation for this source.

8. For this citation, you have the article “Gender and Peer Response” by Elizabeth Tomlinson from the academic journal *Teaching English in the Two-Year College*. Review the scans of the pages of this article found through the online learning system or at <http://kosmicki.com/102/journalexercise.pdf> . Use the information found on the page scans to format a complete APA citation for this source.

9. For this citation, you have an article by David J. Tenenbaum from the academic journal *Environmental Health Perspectives* that you found in a database. The title of the article is “Food vs. Fuel” with a subtitle of “Diversion of Crops Could Cause More Hunger.” You need to find this article in one of the full-text academic databases that you have been given access to (we recommend either WilsonWeb or Academic Search Premiere) and then cite it in APA format as a journal article from a database. Be sure to look at the actual article, not just the listing. *(Hint- One database has the article listed by only the title – the other has it listed only by the subtitle, but both have the same pdf version that clearly shows both the title and the subtitle – as should your citation).*

10. For this citation, you have the webpage found at <http://www.ovw.usdoj.gov/docs/stalking-victimization.pdf> and which was a link from this page: <http://www.ovw.usdoj.gov/aboutstalking.htm> . Go to these links and find the necessary information to write a complete APA citation for this information found on a website.
